Voters can cast:

- I. Three (3) votes to the post of Vice Presidents
- II. Three (3) votes to the post of Representatives to NRAI
- III. Three (3) votes to the post of Representative to Olympic Association
- IV. Four (4) votes to the post of Executive Committee.
- V. One (1) vote in all other posts.

GUIDELINES

- 1. A candidate cannot contest in more than one post.
- 2. Any posts that remain vacant, will be filled through nomination by the elected body.

- 3. The person who propose or second a candidate should be in the valid voters list.
- 4. There shall be no voting by proxy.
- 5. There shall be no voting by post.
- 6. A person who is or who's immediate relation is an arms or ammunition dealer will not be eligible to be elected to any of the posts (Clause 23(c) of the bye law of KSRA)
- 7. The person contesting to the posts of Secretary and Treasurer shall not be an office bearer of any other Sports Association, except their respective District Rifle Association, Kerala Olympic Association and Kerala Sports Council.
- 8. The district units has to produce No Dues Certificate issued by the Treasurer, KSRA for casting their votes in the elections.
- 9. Voters should produce an identity card with Photograph.
